## **THE SCHEDULE OF APPROVAL**

### **1. PRODUCT DESCRIPTION :**

#### **"VOYAGER PU"**

Homogeneous vinyl floor covering with a polyurethane surface treatment, total thickness 2 mm.

Weight per unit area: 3200 g/m<sup>2</sup>.

Composition of this floor covering is:

- upper layer: polyurethane surface treatment, surface density 5 g/m<sup>2</sup>.
- bottom layer: PVC flooring, thickness 2 mm and surface density 3195 g/m<sup>2</sup>.

This floor covering was tested bonded to a non-combustible calcium silicate board (12 mm thick, density 870 kg/m<sup>3</sup>), using F Ball & Co "Styccobond F44" adhesive (application rate: 200 g/m<sup>2</sup>).

3.1 - Test report N° 26/01377A/03/12 dated 15/05/2012 as per IMO Res. MSC.307(88), FTP code 2010, Annex 1, Part 5 (surface flammability), from BCTC laboratory, UK.

3.2 - Test report N° 2601377/03 dated 11/04/2012 as per IMO Res. MSC.307(88), FTP Code 2010, Annex 1, Part 2 (smoke and toxicity), from BCTC laboratory, UK.

### **4. APPLICATION / LIMITATION :**

4.1 - The fitting aboard to be the same as used for the tests.

4.2 - This product is to be used as floor covering or primary deck covering only.

### **5. PRODUCTION SURVEY REQUIREMENTS :**

This certificate does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. To this end, the production-control phase module D "Production Quality Assurance" or E "Product Quality Assurance" or F "Product Verification" of Annex B of the Directive is to be complied with and controlled by a written inspection agreement with a Notified Body.
