1. PRODUCT DESCRIPTION :

"VOYAGER XL"

Homogeneous single layer PVC floor covering, thickness 2.0 mm and weight per unit area of 3200 g/m².

This floor covering was tested bonded to a non-combustible calcium silicate board (12 mm thick, density 870 kg/m³), using F Ball & Co "Styccobond F44" adhesive (application rate: 200 g/m²).

4.2 - This product is to be used as floor covering or primary deck covering only.
